The total minimum number of hours required for graduation with a Bachelor of Arts degree is 120 hours, with a minimum of 40 hours upper division credit (300- or 400- level classes). Also, students must complete 39 hour of the Essential Studies (ES) program in addition to the Legal Studies major requirements.

Some courses are offered every other year. Consult your advisor for course rotation information.

Electives in Legal Studies consist of class offerings from three focus areas: Commercial (LS 332, 343, 434, 435, 444); Litigation (LS 233, 331, 334, 432, 433); and Public Law (LS 235, 236, 333, 432, 438).

A student pursuing a major must complete three (3) elective courses from each of the focus areas as well as core courses (total 48 hours).

A student pursuing a minor must complete LS 231, 238, 337, and 436, as well as one course (3 hrs) from each focus area (total 21 hours).

A transfer student's schedule may vary significantly. Consult your advisor for more information.

A Legal Studies internship may be taken any time during the junior or senior year subject to approval by the advisor and Internship Coordinator, availability of work positions, and qualifications of the appli
