## **PLACEMENT REPORT**

### **2015 - 2016**

Each year the Office of Career and Academic Planning Services produces a report about the previous year's graduates. This report covers graduates that received Bachelor's or Master's degrees. This information is intended to assist currently enrolled and prospective students in selecting academic majors and making career decisions.

Information was collected through the use of surveys sent to graduates in May and October. An electronic survey was also available and noted in the mailing. This report represents 27% of Bachelor degree graduates, and 38% of Master degree graduates.

A list of the specific job titles, employers and employment locations of these graduates is available from the Office of Career and Academic Planning Services.

Of the Undergraduate degree respondents, 63% report working in a related field, and 16% report attending graduate school. Of the Graduate degree respondents, 84% report working in a related field, and no response report attending additional post graduate school.

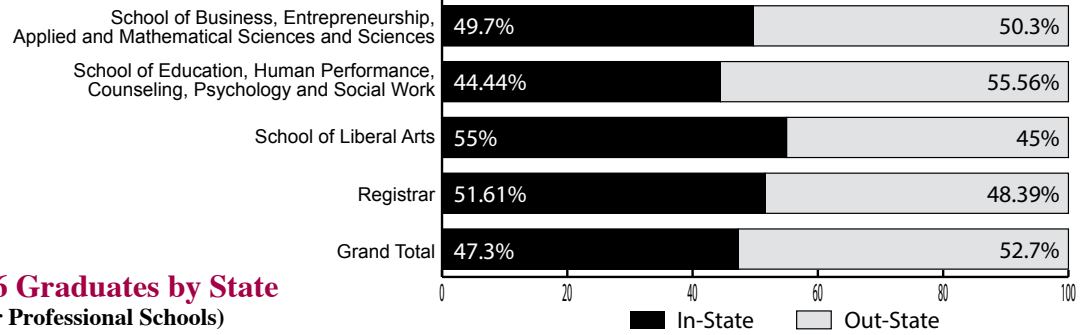

**In-State vs. Out-of-State Pursuits of 2015 - 16 CSC Graduates**

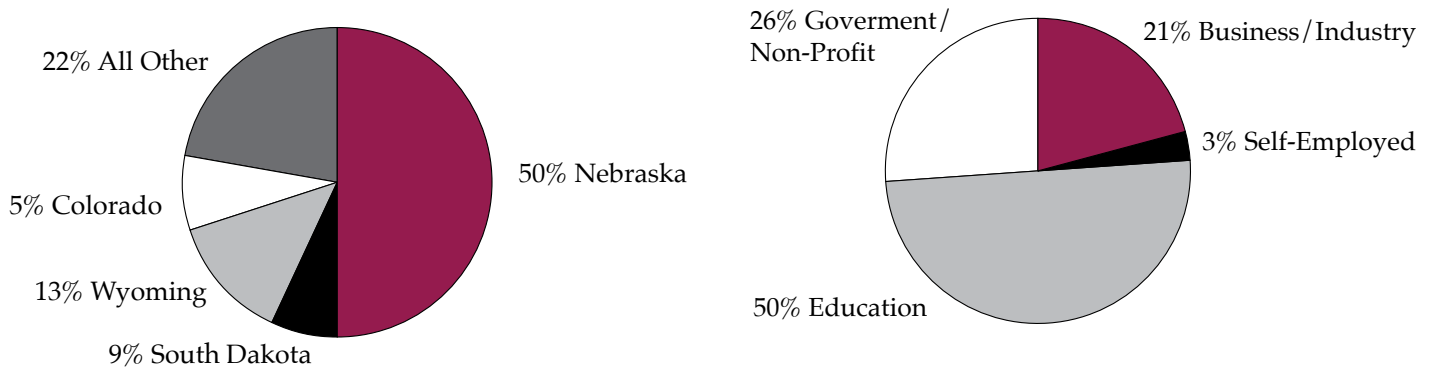


**Locations of 2015 - 16 Graduates by State (Including Graduate or Professional Schools)**
