PART A—PROOF OF RESIDING IN NEBRASKA FOR 180 DAYS. The minimum of 180 days must immediately precede the application for resident status. Acceptable documentation includes lease agreements, cancelled checks for rent, utilities and/or mortgage; paycheck stubs for employment; and/or other substantiating records documenting a home has been established in Nebraska where he or she has been habitually present for a minimum of 180 days. Students living in housing provided by the College while enrolled must prove permanent residence in Nebraska during any period not enrolled at Chadron State, Peru State or Wayne State College.
