 - b. Option 2
 - i. Open <u>csc.edu</u>
 - ii. Select the Resources button in the top right (the hamburger)
 - iii. Select 'Eagles360'
- 2. Log in using your EagleMail credentials.
- 3. Search for the student in the search bar and select the student.
